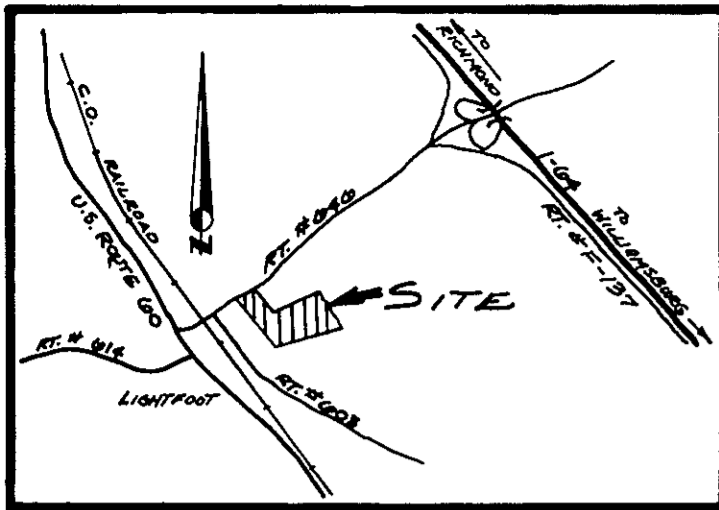

1"=2,000'±

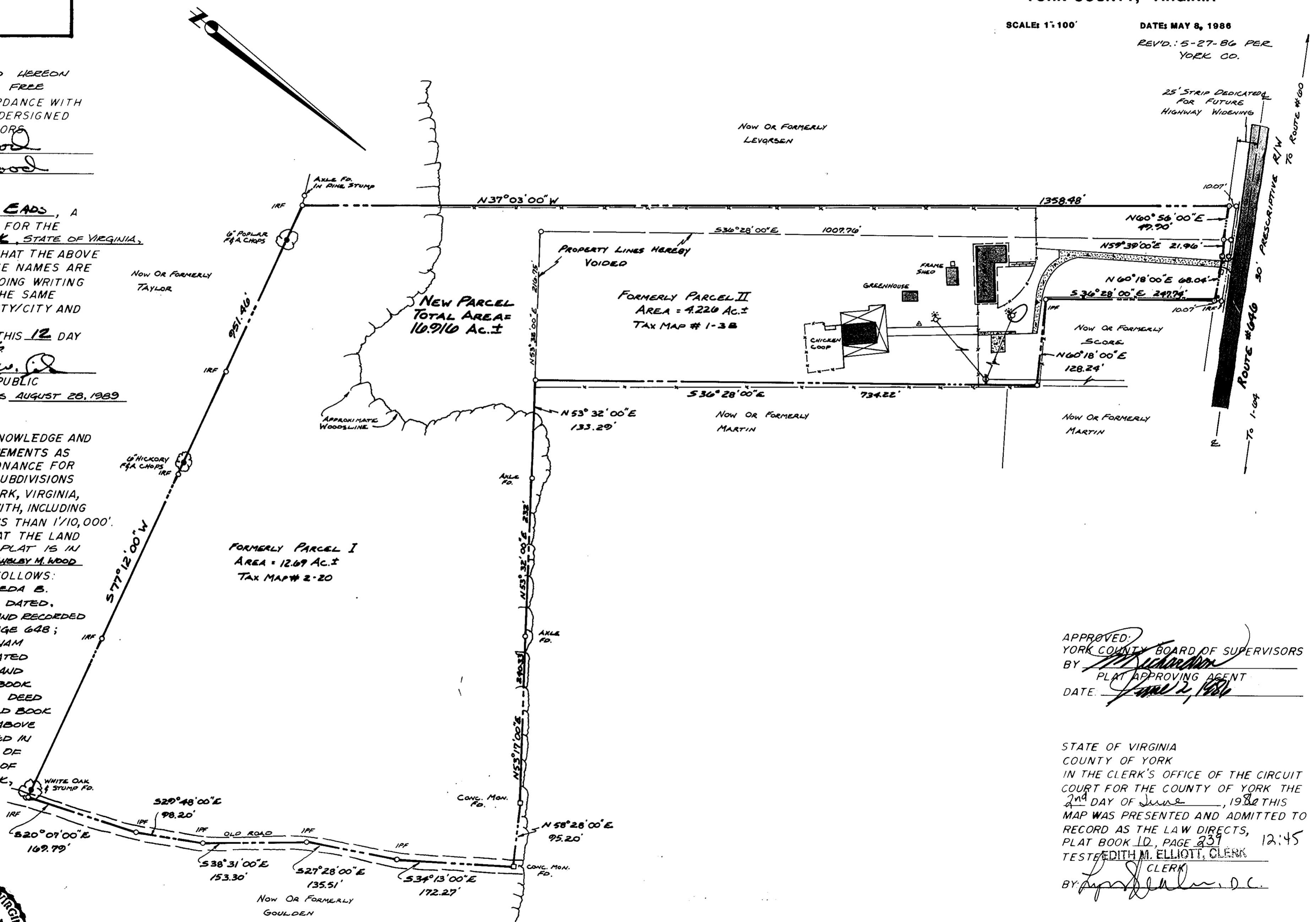
