

- THIS PLAT WAS PREPARED WITHOUT THE BENEFIT OF A TITLE REPORT. THE BOUNDARY LINES OF THE AREA HEREBY SUBDIVIDED BY THIS PLAT ARE TAKEN FROM RECORD PLAT, RECORDED AS INSTRUMENT #120007642. THE EXTERIOR BOUNDARY LINES SHOWN HEREON ARE TAKEN FROM RECORD PLAT, RECORDED IN INSTRUMENT #050020053
- 2. PROPERTY LIES IN ZONE X, AREAS DETERMINED TO BE OUTSIDE THE 0.2% ANNUAL CHANCE FLOODPLAIN PER F.I.R.M. MAP 51199C0185C. EFFECTIVE DATE JUNE 16, 2009.
- 3. ALL COMMON AREAS ARE TO BE CONVEYED TO THE RIVERWALK TOWNES HOMEOWNERS ASSOCIATION.
