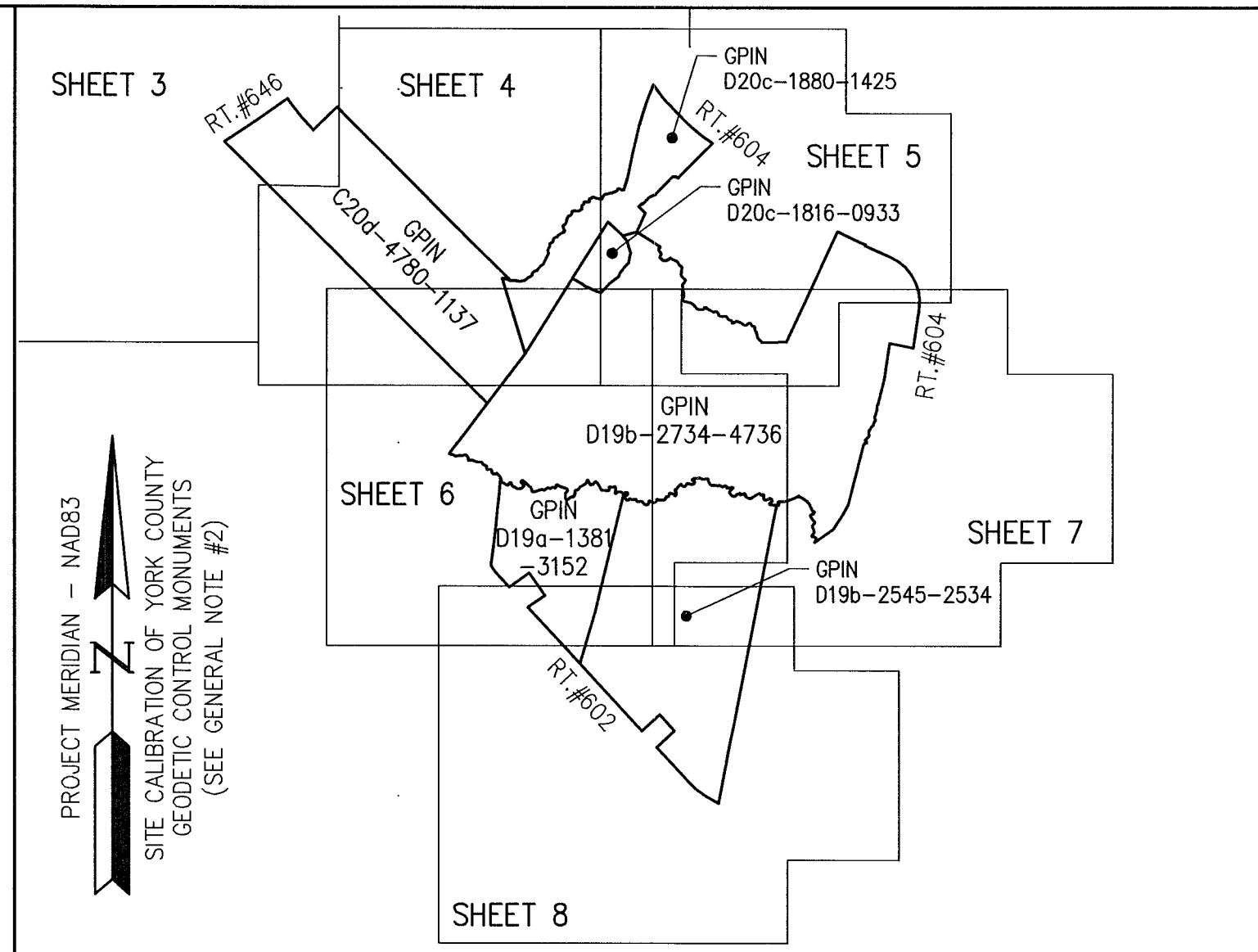

- AREAS OF SURVEYED PARCELS ARE COMPUTED TO THE CENTERLINE (C/L) OF STREAMS; THE STREAM LINES SHOWN ARE TAKEN FROM AN AERIAL SURVEY PERFORMED BY QUANTUM SPATIAL [TERRESTRIAL LOCATIONS OF THE STREAM LINES NEAR AND ADJACENT TO PROPERTY LINE MONUMENTS & INTERSECTIONS WERE FIELD OBSERVED BY AES], THE MAPPING SCALE OF THE AERIAL SURVEY IS 1 INCH = 50 FEET AND COMPILED BY PHOTOGRAMMETRIC METHODS FROM AERIAL PHOTOGRAPHY DATED 4-28-2018.
