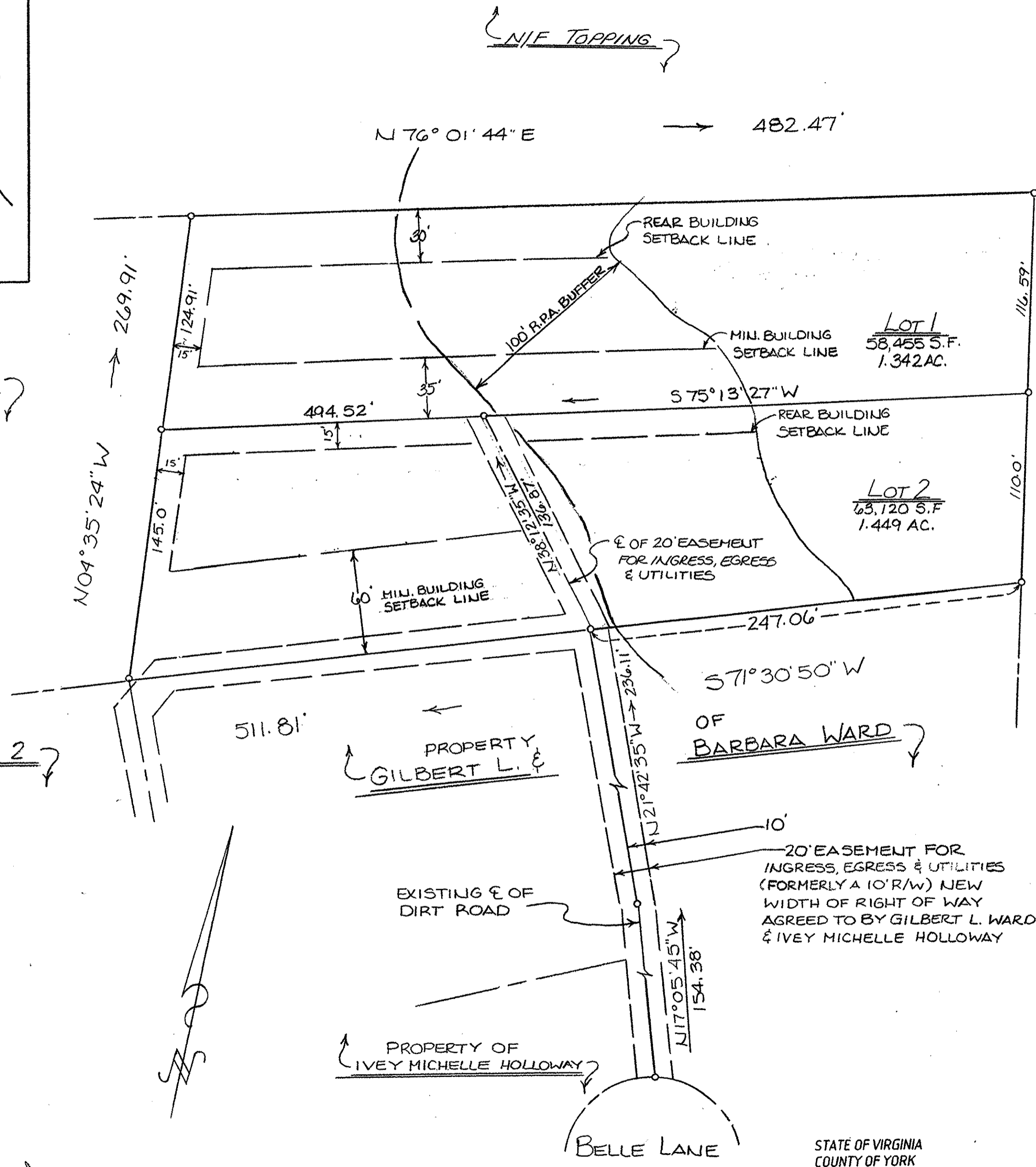


VICINITY MAP 1" = 2,000'

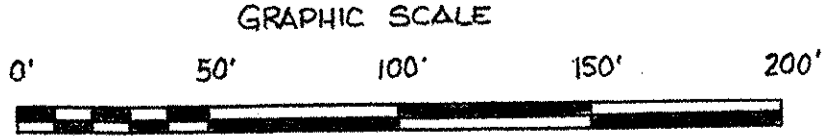
