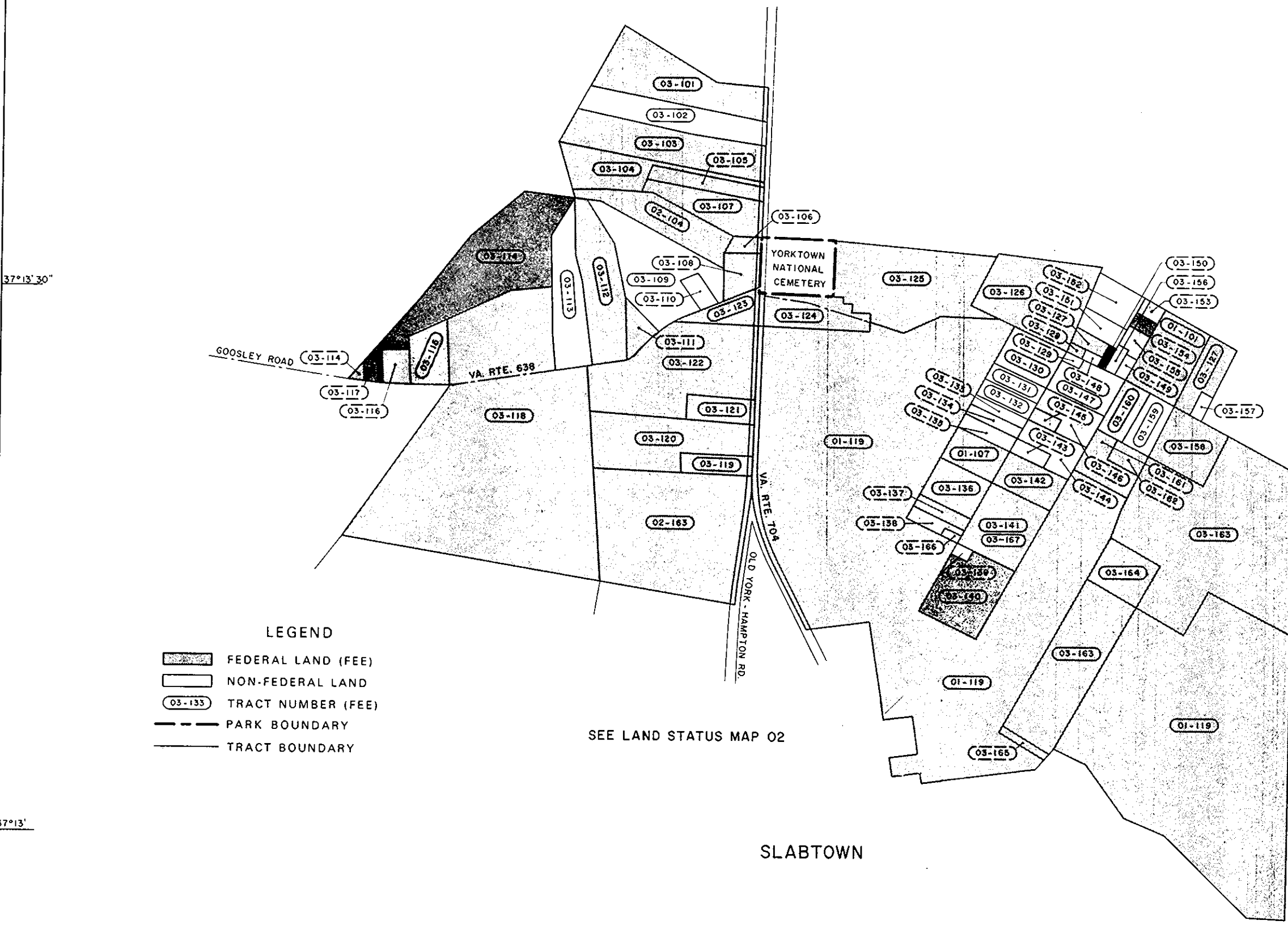


SEE LAND STATUS MAP 01

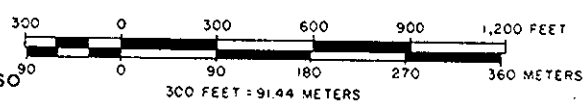
