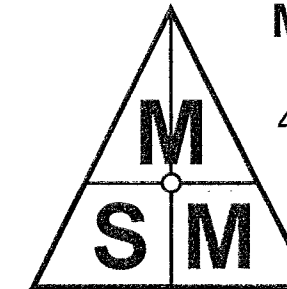


BOUNDARY LINE VACATION PLAT
