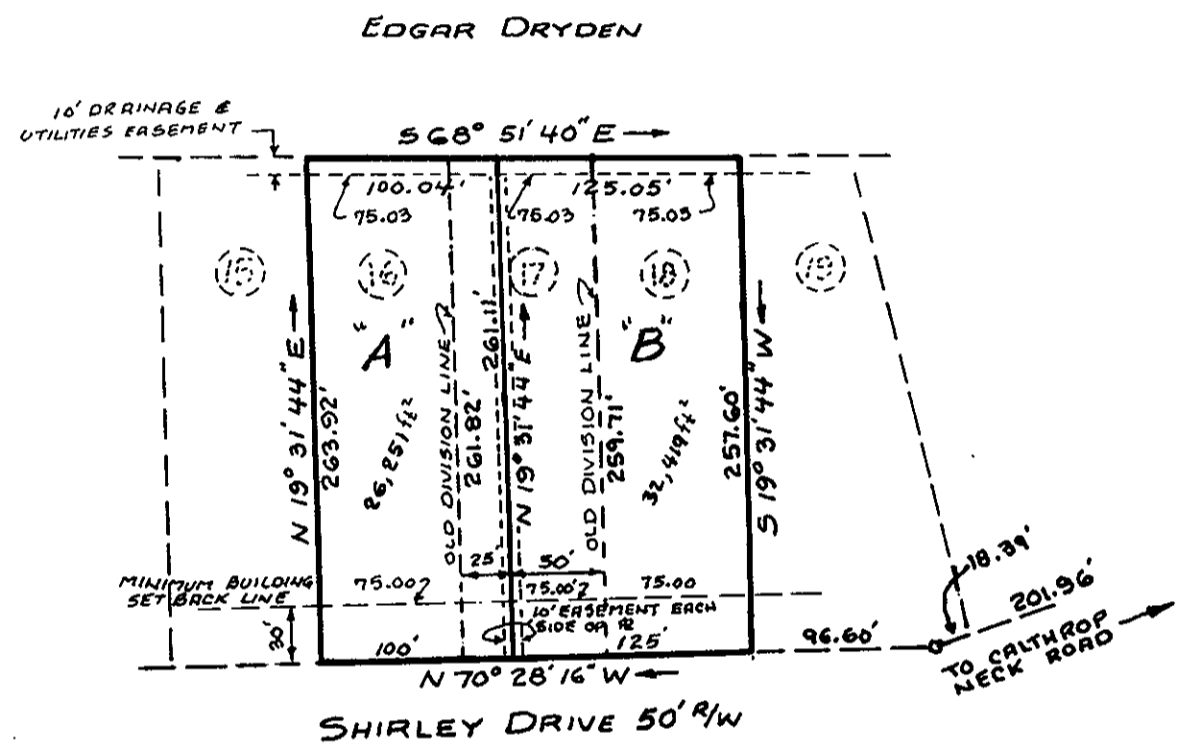
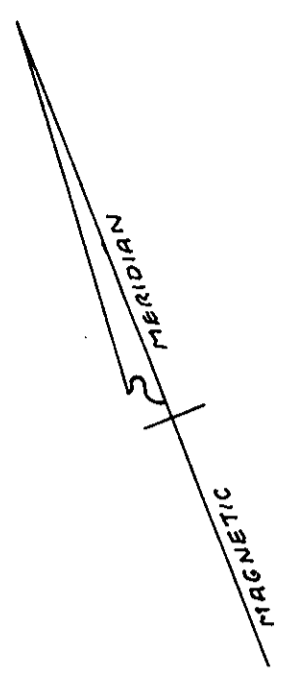


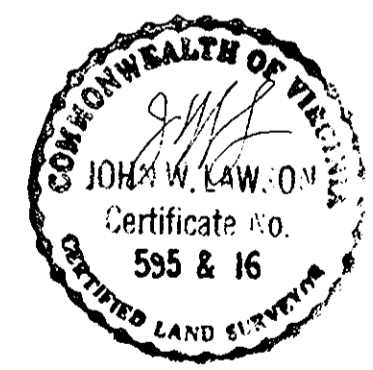
VICINITY SKETCH
