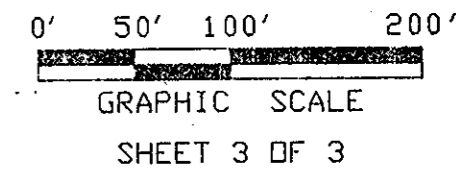


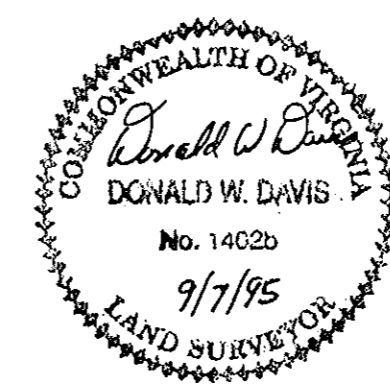
THE WOODS OF TABB SECTION SIX

SCALE: 1" = 100' DATE: 7 SEPTEMBER 1995

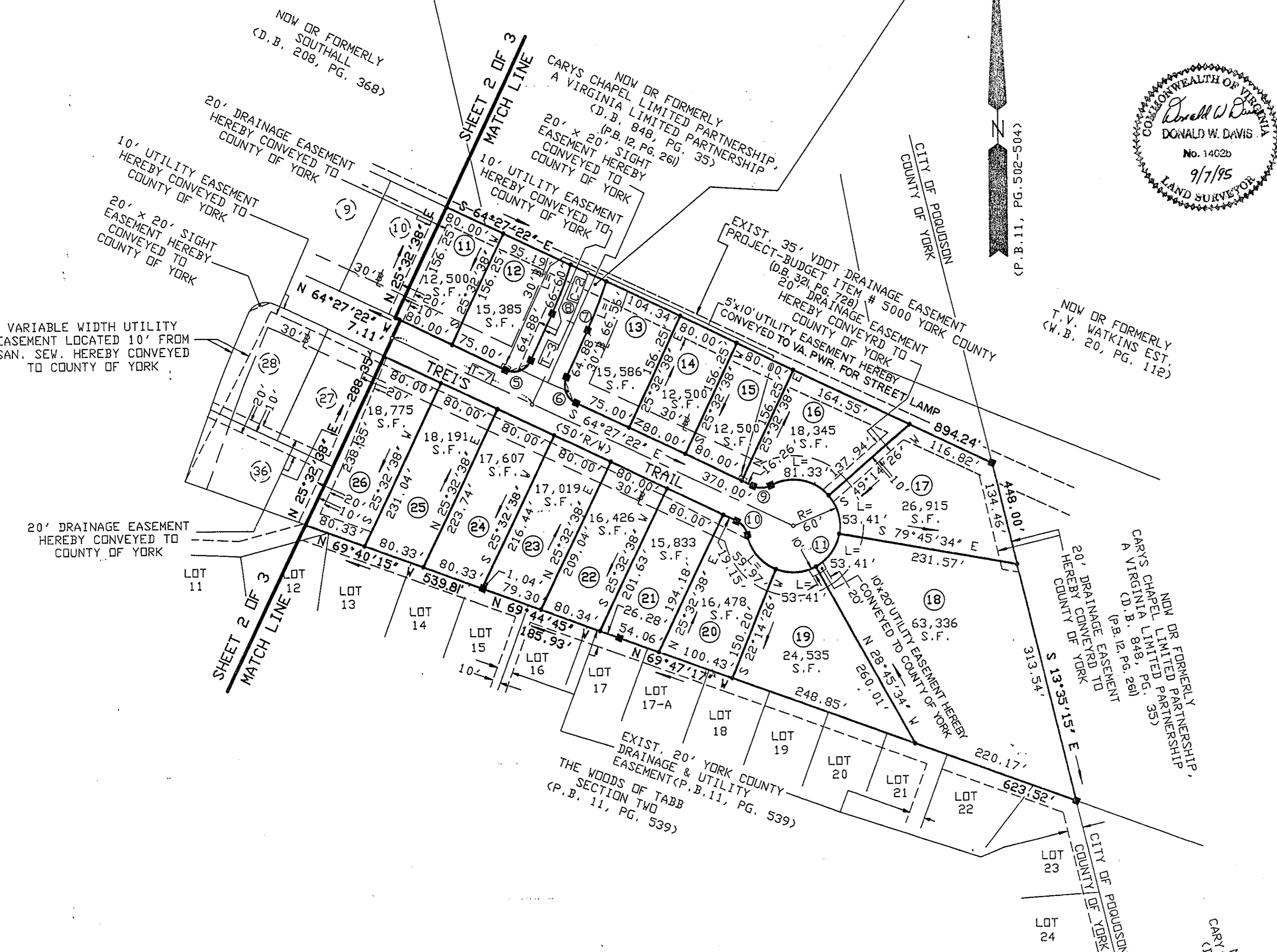
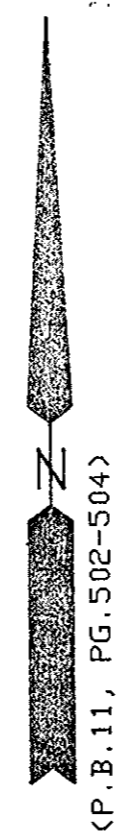
